MEMORANDUM OF UNDERSTANDING

SIDDHARTH COLLEGE (B.M.M., B.M.S and B.Com) BORADPADA, P.O CHARGAON, DIST.THANE – 421 503

This Memorandum of Understanding (MoU) is made on this 24th August 2021 by and between SHREE RAM POLYCLINIC AND AYURVEDIC DAVAKHANA (Hereinafter called the 'FIRST PARTY') and NAMITA EDUCATION AND WELFARE SOCIETY'S SIDDHARTH COLLEGE (B.M.M., B.M.S AND B.COM), (Hereinafter called the "SECOND PARTY)'.

Both the Parties are located in the same area viz. Village:Boradpada, P.O Chargaon, Taluka:Ambernath, Dist.Thane, Maharashtra.

A good number of college students belong to nearby tribal areas of the College. They hardly go to hospitals when they fall sick. These students, at times, cannot afford to pay even a small amount of consultation fee to the Doctors. Therefore, having a mutual understanding, both parties have agreed as under.

- 1. It is agreed between the parties that the sick students will be referred to Shree Ram Polyclinic and Ayurvedic Davakhana for free treatment.
- 2. Dr.Aashish Kumar Mishra of Shree Ram Polyclinic and Ayurveda Davakhana agreed to visit the college on Wednesdays between 11.30 am to 02.00 pm and attend the students concerning their health. The services rendered by Dr.Aashish will purely be on voluntary basis.
- 3. Dr.Aashish also agreed to act as the Counsellor during his Wednesdays visits to the college.
- 4. The First Party agreed to hold Health Check-ups of the students once in Six months with regard to the weight, Blood Pressure, Pulse and General Examination of the students. The incidental expenses of the same will be borne by the Second Party.
- 5. It is mutually agreed that the medicines of students that would be prescribed by the First Party will be managed by the Second Part.
- 6. The First Party will help in referring the sick students, in coordination with the Second Party for further treatments in other nearby hospitals/clinics, if needed.
- 7. The Parties agree that this MoU shall be for a period of Three (03) years effective from 01st September 2021. Each party has the right to terminate this contract without cause with a minimum of 30 days written notice prior to termination.

- The essence of this MoU is to establish accord and exchange various resources available like technical knowledge, research facilities, literature in the form of books, periodicals, journals, teaching and training aids with J.Watumull Sadhubella Girls College, Ulhasnagar and Siddharth College, Boradpada.
- 3. Following are the exchange activities agreed upon by both parties on their respective academic and educational needs.
 - a) The exchange of scholars
 - b) Exchange of students
 - c) Material exchange between researchers
 - d) Holding conferences jointly

- e) Research programs be conducted in collaboration
- f) Any other academic exchange that may be agreed upon
- 4. All the exchange programs referred above will be implemented as per the mutual agreement by both the parties. Efforts will be made by both parties to find financial resources for carrying out the activities listed above.
- 5. No constraints will be imposed by either upon the other in carrying out the agreement.
- 6. This agreement shall be in force for a period of 5 years from the date of this agreement and is subject to revision or modification by mutual agreement. It is also understood that this agreement may serve as the basis for specific agreements to be developed at a later date. It is further understood that either institution may terminate the agreement at any time, upon one-year written notification to the partner institution, although such action will only be taken after mutual consultation in order to avoid any possible inconvenience to either party.
